		<ul> <li>Individuals do take LFT if they have tested positive for coronavirus within the last 90 days and were asymptomatic at the time of testing.</li> <li>Staff are advised to continue to test in line with the usual school protocols and within the 90 days if they have tested positive but have ended their isolation period having tested negative with a Lateral Flow Test on two occasions (day 6 and 7 up to day 9 and 10).</li> <li>If the member of staff has tested positive using an LFT on day 10 but is able to return to work, because they have completed the isolation period and no longer have a temperature, then we would not expect them to test again within the 90-day period unless they exhibited symptoms again.</li> <li>Testing kits are stored indoors between a temperature of 2 to 30°C.</li> <li>Individuals are instructed to collect test kits from the main office.</li> </ul>
