## September Arrangements Updates

Following the letter you received this morning, some of you have been in contact with school regarding the timings of drop off and collection, and shared your frustrations regarding these.

During the 'meet your teacher' sessions this morning, I was fortunate to be able to talk through these arrangements with some you, and share a possible alternative. The main issue surrounding the initial arrangements was the staggered start and end to the day and how this affects working parents.

## Revised beginning and end of day arrangements

- Only one adult per child is permitted to come to school to drop their child off. There should be no gatherings on the school site. Any younger siblings must not leave their adult.
- Avoid parking cars on the school site to avoid congestion. Please park on surrounding streets and walk to school.
- Parents will not be permitted through the gates to the meeting place. Y1 & Y2 children will walk in by themselves to the KS2 playground.
- Y1 & Y2 children will be greeted by their class teacher on the KS2 playground, EYFS staff will meet the children at their designated gate and take them to their classroom.
- If you have children in two year groups, please use the allocated gate and time for the youngest child.
- At the end of the day, please wait at your designated gate, the teachers will bring the children to you.
- It is more important than ever that you are on time.
